**PROPOSED RESOLUTION AT THE EXTRA ORDINARY  
CONFERENCE TO AMEND THE PROVISIONS OF THE  
CONSTITUTION CONCERNING NUMBERS OF DESIGNATED  
COUNCILLORS AND TO INCREASE SOME OF THE SAID NUMBERS  
AS STATED IN THE PROPOSAL.**

**Preamble:**

With reference to the OBJECTS of the WF (KSIMC) under Section 4 of the Constitution, there now demands wider and sharper VISIONS to meet and manage the CHALLENGES ahead to keep achieving the Objects satisfactorily as hitherto, in the face of the continuing processes of development in the environment of Globalization which affect in various degrees almost all spheres of life. There is now therefore the need to strengthen the representative composition of the Executive Council by increasing the numbers of some of the designated Councillors and the increases proposed are stated in the Proposed Resolution.

The Proposal takes into also account that full attendance of all Councillors is not normal like in any other organizations. There can arise circumstances when even normal attendance of Councillors may not be possible. With the proposed increase in the numbers of Councillors, the proceedings of the Executive Council will, insha Allah, not be affected.

Under Section 17:2 of the Constitution, this Conference has the Power to amend the Constitution as proposed, and further, the Resolution proposed is not subject to any constitutional restrictions appearing under the provisions of the said Section 17.

The Notice for moving the Proposed Resolution conforms to Section 17.2.4 of the Constitution.

Therefore, in view of the foregoing observations, the Federation of Khoja Shia Ithna-Asheri Jamaats of Africa (AFED) is proposing the following amendments to the WF Constitution by a Resolution which reads as follows:

## **RESOLUTION**

**IT IS HEREBY RESOLVED that:**

**Under Section 19.1.1 (item 7)**

**the number of Ordinary Councillors be increased from Five (5) to Ten (10)**

**Under Section 19.1.1. (item 8)**

**the number of Nominated Councillors be increased from Five (5) to Ten (10).**

**Under Section 19.1.2 (item e)**

**The number of Appointed Councillors be increased from Five (5) to Ten (10)**

**Under Section 19.1.2 (item f)**

**The number of Nominated Councillors where reading Five be increased to and read Eight**

**The Resolution to take effect upon adoption.**
